

Surety Bond

On the basis of NEET P.G. 2018 merit I was offered by the State PG medical/Dental Admission/Counseling Board-2018 various course(S) of various institution(s) at the time of my counseling and I have voluntarily opted for the MD/MS course (Name of subject) in Geetanjali Medical College and Hospital, Udaipur with the understanding and subject to the undertaking that I shall take admission in the college on full time and regular basis and shall maintain the required standard of performance and shall not indulge in indiscipline/misconduct.
